This project consists of the supply and installation of approximately thirty (30) air conditioners, forty (40) refrigerators, and fifty (50) general contractor works orders, and the removal and disposition of the existing air conditioning and refrigerators units at WAP eligible homes throughout northern and eastern regions of Puerto Rico (as specify in the Bid Documents). All work to be done will be in accordance with the Contract Documents.

Bidders shall be submitting Proposals, in accordance with the Instructions to Bidders contained in the Bid Package, no later than Friday, August 9, 2013 at 12:00 PM (noon). A compulsory pre-bid conference will be held on Monday, July 29, 2013 at 2:00 PM. The mandatory Pre-Bid Meeting will be held at PRIFA's offices located on 268 Muñoz Rivera Avenue in World Plaza Building, Fourth (4th) Floor, Hato Rey at Engineering Department Conference Room.
