The works will be executed in the municipality of Humacao, Puerto Rico at the Special Communities. The Cangrejos Community project consist of the demolition and debris disposal of three (3) existing abandoned structures, as well as the construction of civil works and grading improvements in an area adjacent to Camino Cangrejos in order to enhance, improve, and restore site. Said civil works and grading improvements include: clearing and grubbing of the site, construction of retaining wall. The Parcelas Martínez project consists of civil works for drainage, grading and erosion control for a street portion. All work to be done will be in accordance with the Contract Documents.

Bid packages can be collected since August 30, 2013 between 2:00 pm to 4:00 pm at PRIFA's offices located on Hato Rey at 268 Muñoz Rivera Avenue in World Plaza building, Fourth Floor, Hato Rey. Bid packages will have a non-reimbursable cost of \$20.00 payable to the Puerto Rico Infrastructure Financing Authority with certified check or money order. Payments in cash will not be accepted.
